SCHEDULED AGENDA ITEMS:

- **Parks Transportation:** Council was presented with the option to purchase a Suzuki Mini truck for the amount of \$4000. They discussed the feasibility and legalities of using a mini truck for city transportation. These trucks, are common in Japan and registered as UTVs in Idaho. While compact, these vehicles are suitable for light tasks like transporting lawn equipment and picking up trash, and a cost-effective alternative to using the expensive tool cat or larger trucks. After discussion, Councilman Patrick Cordova made a motion to approve the purchase of the Suzuki mini truck for \$4,000, with the stipulation that the City can legally register and insure it for use within the city. Councilman Bill Abbott seconded the motion. ***Motion Carried.***
- **TREE PLANTING:** Council reviewed and discussed Rich Schafer's proposal for seedlings and planting. After a brief discussion, Councilman Bill Abbott motioned to approve the proposal from Rich Schafer to plant 9000 seedlings on the City property on Moscow Mountain for the cost of \$7660. Motion was seconded by Councilman Patrick Cordova. ***Motion Carried.***
